NOTICE OF INTENT TO VACATE A PLATTED STREET AND ALLEY

Pursuant to K.S.A. §58-2613, notice is hereby given that the Board of County Commissioners of Crawford County, Kansas proposes to close and vacate the following platted street and alley, to-wit:

An unnamed alley located adjacent to and North of Lots One (1) through Three (3) in Block One (1) in P.C. Guinn's First Subdivision of the Southeast Quarter (SE  $\frac{1}{4}$ ) of the Southwest Quarter (SW  $\frac{1}{4}$ ) of Section Thirty-one (31), Township Thirty (30) Range Twenty-four (24) Crawford County Kansas, according to the recorded plat thereof; and

An unnamed street located adjacent to and East of Lot One (1), Block One (1) in P.C. Guinn's First Subdivision of the Southeast Quarter (SE  $\frac{1}{4}$ ) of the Southwest Quarter (SW  $\frac{1}{4}$ ) of Section Thirty-one (31), Township Thirty (30) Range Twenty-four (24) Crawford County Kansas, according to the recorded plat thereof.

A public hearing regarding said proposed road vacation will be held on Friday, March 27, 2020 at 10:00 a.m. in the Crawford County Courthouse, 2nd Floor, Commission Room, Girard, Kansas. All interested persons are encouraged to attend the public hearing.

If the Board of County Commissioners determines that the above-described platted alley and street are no longer required, or cannot be prudently be used for public purposes, the land comprising said alley and street shall revert to the adjoining landowners as originally taken for One Dollar (\$1.00), in the Commission Room at the Crawford County Courthouse, Girard, Kansas, on Friday, March 27, 2020 at 10:00 a.m.

This notice shall be published one time in an official County newspaper.

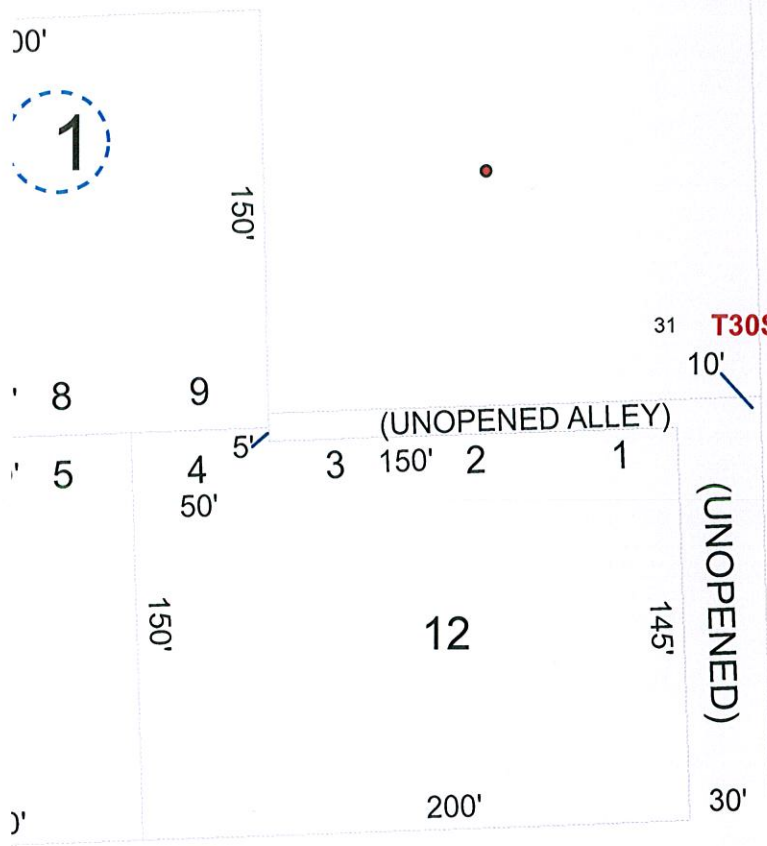
