



Crawford County Board of Canvassers Meeting April 18, 2023

The Board of County Canvassers met at 10:00 AM, Tuesday, April 18, 2023 to canvass the ballots from the 2023 City of Pittsburg Sales Tax Special Election held April 11, 2023

Chairman Bruce Blair served as the presiding officer.

Canvassers Tom Moody and Carl Wood were present.

County Counselor Jim Emerson, Chief Election Officer Lisa Lusker and Director of Elections Gene Rountree-García were seated with the Board.

Original Canvass from the 2023 City of Pittsburg Sales Tax Special Election held April 11, 2023, before the Crawford County Board of Canvassers.

Ms. Lusker presented the Provisional Ballot Reconciliation. Ms. Lusker explained the report to the Board. Commissioner Moody discussed the cost of the election with Ms. Lusker.

 - i. Seventeen advance ballots returned undeliverable
 - ii. Three advance ballots returned and voter was deceased prior to election day
 - iii. One advance ballot received and postmarked after election day
 - iv. Seven advance ballots spoiled or lost
 - v. Five advance voters moved within county but did not return provisional ballot
 - vi. One provisional ballot for a voter that was not registered in USD 250
 - b. Those recommended to be counted**
 - i. Two voters that moved within the voting district
 - ii. Two clerical errors

- iii. Two voters who voted at the wrong polling place
- iv. One voter was mailed ballot but voted at polls on election day

Ms. Lusker asked that the Canvassers approve the ballots recommended for counting and for not counting as presented by the County Clerk.
