Item One: Mr. Glenn Peak from Cherokee, Kansas addressed the Commissioners in reference to solar panels and Heartland Electric. He discussed the information that people receive about Heartland Electric and that he believes it is misinformation that they are receiving. Commissioner Moody asked if Mr. Peak was speaking about individual home owners and Mr. Peak confirmed that he is. Commissioner Wood said he believes scams have been going around. Commissioner Blair mentioned some areas will buy electricity back but at a cheaper rate and that he will call Heartland Electric himself to gather some information in regards to this. County Counselor Jim Emerson provided Mr. Peak with the Attorney General's Office number to report this. Mr. Peak also spoke about mail boxes on county right of ways. He asked if one of those mail boxes get hit who will be responsible and Mr. Emerson mentioned both the homeowner and the county would be held accountable. Mr. Peak mentioned he believes all of these mailboxes need to be made breakaway and that it cannot be done that way if someone has brick and concrete mailboxes. Commissioner Blair explained it can be done with brick and concrete as a result of how the bottom layer of the mailbox is crafted. Mr. Peak went back to wind and solar panels and that something needs to be in place that after the wind turbines or solar panel expires that they are cleaned up appropriately and the Commissioners stated there is something in place for the wind turbines.

MESSAGES FROM APPOINTED OFFICIALS

Item One: County Grant Writer Gus Brunetti addressed the Commissioners in reference to grants available. Commissioner Wood asked Mr. Brunetti about the conference he attended and if he felt it was beneficial and Mr. Brunetti answered that he did learn a bit and that he noticed a lot of grants were for cyber security as well. He mentioned one

thing he discovered is they have added the Bill of Kansas Fund which he explained as a match source for smaller communities. Mr. Brunetti stated most of those grants are a 75% to 25% match so that they could apply through the smaller communities to save some money. He gave information in regards to a few other grants as well as what they are used for. Mr. Emerson mentioned looking into the grant that improves bridges. Mr. Brunetti is going to look into this grant as well as the information needed for it. Commissioner Blair asked about the Emergency Management grant that helps with flooding and Mr. Brunetti said he will look into that and contact Commissioner Blair. Commissioner Wood asked if Mr. Brunetti could make a list of the grants he just listed and he answered that yes he can.

Commissioner Blair asked if this is a list of what they want done or what they have done and Mr. Emerson explained the list is what they have repaired on their own throughout the years. Commissioner Wood asked if this is to replace an air unit and Mr. Emerson confirmed. Commissioners agreed they would like to see the bids before making any decisions and Mr. Emerson stated he will get a copy of them.
